COURSE DESCRIPTION

Math 980 includes algebra topics such as: linear equations; graphing; systems of linear equations; linear inequalities and absolute value; exponential and logarithmic functions. According to university guidelines, an average student should expect to spend 8-12 hours per week outside of class in addition to the time in class. Some students will get by with less, others may need more time.

PREREQUISITE: If your Math ACT score is below 14, please speak with me immediately!

For the School of Business, College of Social & Behavioral Sciences*, College of Education*, Colleges of Science, Engineering, Mines & Earth Sciences and Architecture + Planning*, students should have a current Math ACT score between 14-17, or on the Accuplacer an EA ≤ 53.

For the Colleges of Humanities, Fine Arts, Nursing Health, Social Work, Social & Behavioral Sciences* and Architecture + Planning, students should have a current Math ACT score between 14-18, or on the Accuplacer an EA ≤ 59.

*Multiple QA options are available or do not follow this specific pathway. Meet with your academic advisor to verify which courses will work best for you.

- ➤ Recommended In-Person Attendance: In-Person Attendance is strongly encouraged but not required. Students may elect not to attend class in-person with no penalty and do not need to seek an official accommodation to participate online, rather than in-person. Please do not come to class if you are experiencing COVID-19 symptoms. Remember to maintain social distancing at all times.
- Attendance & Punctuality: Students are expected to attend the class, either in person or via Zoom, during the listed class time. Classes will be recorded when possible, but the class is designed with active participation in mind and students benefit most when present during the live class. Participation during class is graded. You need to be present in the online class in Discord to participate in Exams. Not being present during an assessment, but turning it in will be considered academic misconduct.
- ➤ COVID-19 Considerations: Students must self-report if they test positive for COVID-19 via coronavirus.utah.edu.
 - Please do not come to class if you are experiencing COVID-19 symptoms. Remember to maintain social distancing at all times. Face coverings are required for students and faculty. Based on CDC guidelines, the university requires everyone to wear face coverings in shared public spaces on campus, including our classroom. - ➤ Course Materials: All coursework will be available through Canvas. The textbook, indicated as Explanation and Examples, is available as the student progresses from module to module. During the first week of school, the student will learn how to log into the coursework and work through the curriculum. Video Lessons and Practice, Homework, and Quizzes were created in OHM an Open Resource Material. The videos and text were developed mainly by James Sousa of Phoenix Community College. Students can download and print the text (Explanation and Examples) for every section.

Technical requirements:

- For both quality learning and proctored testing, students are required to have access to the following equipment:
 - A strong internet connection with sufficient bandwidth (in order to participate in IVC classes, access course materials, and take exams):
 - A webcam on your computer or camera on your phone (this is required for taking exams on Discord; it is recommended for IVC lecture classes):
 - A scanning device which is different than the device you are using for your webcam (smartphones can be used as scanning devices)
 - a microphone (used for online meetings);

- Students are expected to be computer literate and Canvas, Zoom and Discord navigation skills are expected. Knowledge and navigation of Canvas, Zoom and Discord is critical to access all features and resources of this course.) Students should log into Zoom for class with audio and video enabled.
- Students are expected to participate in the IVC portion of class, which is done through Zoom, with audio and visual enabled. This expectation is there, because it improves learning and the classroom environment. If students need to turn of cameras and/or microphones, this is allowed. It is polite if you will be doing so for long periods to inform your instructor. Also note, even though microphones are enabled, they may be muted when not in use.
- During exams, students are required to have audio and microphone and to have it enabled (students may be asked to mute your microphone for portions of the assessments.) Students need to position the camera and/or themselves so that their head, hands and workspace is visible. Students are required to have a separate scanning device and continue to have their Discord camera turned on while scanning; during the scanning phase, students may be gone from the screen for a few seconds if this is prearranged with their instructor.
- A printer is recommended, but not required, so that you can print out templates for exams ahead of time.
 If you do not have a printer, you will need to make and use hand-written versions. You must copy these exactly, but they are designed to be fast and straight forward to create by hand.

- A scientific calculator is required for the course. Students are allowed (as per instructor's restrictions) to use calculators provided they show clear/precise work on every problem on the midterms and the final exam in order to receive full credit for correct answers. No graphing calculators, cell phones or devices with Internet connectivity may be used as a calculator on an exam.
- > Syllabus subject to change: This syllabus is meant to serve as an outline and guide for our course. Please note that I may modify it with reasonable notice to you. I may also modify the Course Schedule to accommodate the needs of our class. Any changes will be announced in class and posted on Canvas.

CONTENT OVERVIEW

The course goal is for students to improve their quantitative reasoning, gaining an understanding of algebra and confidence in Mathematics.

COURSE EXPECTED LEARNING OUTCOMES

- 1. Students will demonstrate competency in:
 - a. solving linear equations; basic power equations; linear inequalities; and systems of linear equations in two variables;
 - b. graphing linear equations; linear inequalities; and systems of linear equations in two variables;
 - c. solving and graphing absolute value equations and inequalities;
 - d. solving and graphing exponential and logarithmic functions;
 - e. solving applications related to the above topics;
- 2. Students will develop confidence and comfort in dealing with mathematical concepts.
- 3. Students will develop concise analytical thinking and problem-solving skills that can be applied in their daily lives.
- 4. Students will demonstrate the ability to incorporate all of the above skills by communicating and presenting a detailed solution to a multi-faceted real life challenge.

CLASS SCHEDULE & IMPORTANT DATES

Mandatory Online Instruction Periods: All classes will be online the weeks of September 28-October 10 and November 30-December 3. During these weeks, we will meet synchronously in Discord at the normal class time.

Exam Dates: The midterm exams will be held during class time on September 28, and October 28. The Final Exam will be held on Tuesday, December 8 from 10:30 am - 12:30 pm.

Official Drop/Withdraw Dates: The last day to drop classes is Friday, September 4; the last day to withdraw from this class is Friday, October 16. Please check the academic calendar for more information pertaining to dropping and withdrawing from a course. Withdrawing from a course and other matters of registration are the student's responsibility.

COMMUNICATION

Communication expectations:

- All course materials, such as assignments, solutions, grades, etc. will be posted on the Course Canvas site. Class announcements will be done via email through the Canvas server. You will be responsible for any information contained in them as well as the information announced in class.
- It is your responsibility to also regularly check your Umail (make sure you set up forwarding if you do not check it regularly). There are times that your Umail is the only way for me to communicate privately with you, there may be occasions during the semester that I may need to reach out to you individually (e.g. regarding a grade or assignment) and it is in your best interest to respond promptly.

A score of 50% or higher must be obtained on the final exam for a student to receive a grade of "C" or better in the course. An average percent will be computed and the final grade will be determined using the following scale:

As your instructor, I will do my best to make sure that all grades are recorded accurately, but mistakes are occasionally made. It is the student's responsibility to ensure the accuracy of all recorded homework, quizzes, online assignments, and exam grades. Also, you should keep a record of all your graded assignments. If you see any error in your grades on Canvas reach out to me as soon as possible, at the latest within two weeks from when the assignment was returned.

CLASS PREPARATION AND PARTICIPATION: During the first week of the semester, students will be required to complete: 1) a Syllabus Quiz, 2) a Code of Conduct assignment and 3) and a Participation Video.

These assignments will not be excused. They are required before students complete much of the coursework and will account for 1% of the overall grade.

Participation will be graded on a combination of attendance and participation during class. Attendance will be taken during each class (both in-person and on Zoom). Students may be asked questions during or immediately after class to learn how well the class is understanding the material. 10% of participation scores will be dropped at the end of the semester. Attendance and participation during class time will count for 2% of the overall grade.

To prepare for each class, students are expected to watch the 'Video Lessons and Practice' including answering the short 'Practice' questions that are embedded in the videos. The lowest 10 scores will be dropped at the end of the semester. Watching the 'Video Lessons' and answering the embedded 'Practice' problems will count for 2% of the overall grade.

HOMEWORK: Homework will be given regularly in Canvas. The homework exercises are the required minimum for you to demonstrate the learning objectives of the course and the mastery of the course concepts. You are encouraged to work more homework exercises than those assigned. Homework questions are designed to reset after the 3rd attempt, so you have an unlimited amount of homework problems. Regular practice is essential in learning mathematics. Most students find the more homework they practice, the better they do on the exams. All students can turn in up to 8 sections of homework up to one week late without any penalty. All homework must be completed before the Final Exam.

REALITY CHECKS: Reality Checks are intended to help you practice applying the recent material in a real-word example. There is one at the end of each module in Canvas. The Reality Checks have no time limit. You will have two attempts at every Reality Check, and the higher of your two scores will be saved.

REVIEWS: There is a graded review assignment for each module in Canvas.

QUIZZES: There is a graded quiz at the end of each module in Canvas. The quizzes are timed. Each quiz will give you two attempts, and there is a Quiz Retake which gives you another two attempts. Your highest score will be saved.

EXAMS: Exams will be given during class time at the dates listed above. The material that will be covered on the midterm exams will be announced at least one week before each exam. The Final Exam will be cumulative. Exams will be proctored on Discord. Students are required to have their head, hands, and workspace be visible, and have microphones turned on. Students can ask their instructor questions using the text feature in Discord. Students should print out or hand-copy the provided template to write answers on before the exam begins.

Late Assignments/Missed Assignments Policies: Several assignments are designed to provide you flexibility via dropped assignments. You are expected to turn things in on time and take exams at the times given unless there are serious extenuating circumstances. If there are extenuating circumstances, please contact me in a timely way to discuss alternatives. If the situation is one that can be documented, you may be asked to provide documentation. If you know about the situation in advance (such as officially sanctioned university activities), contact me at least one week in advance of any such obligations to arrange accommodation.

Incompletes: According to university policy, to be considered for an incomplete, a student must have 20% or less of the course work remaining and be passing the course with a C or better. You must request an incomplete grade and I will consider giving that grade only under exceptional circumstances.
